

The Art Club at Halfpenny Green Winter Exhibition

28th September to 24th October at Russells hall Hospital

- All work must be an original painting by an artist who attends the art club at halfpenny green
- Entries are open to art club members who have been to a session in 2026
- Art work can be any subject providing it doesn't violate the The Dudley Group NHS Foundation Trust terms (see below*)
- All art work entered must be for sale
- Art work can be any medium we practice at art club; Watercolour, acrylic, pencil, pen and wash
- All Pictures must be framed with D rings and hanging string attached. If submitting an unframed canvas then the edges must be (painted) finished and D rings and hanging string attached.
- All work is exhibited at the owners risk and no responsibility/liability for loss or damage will be accepted by the Trust, or The Art club at Halfpenny Green. (Artists may wish to consider taking out their own insurance.)
- The Artist will be required to pay **20%** commission on sales at the end of the specified period. Please take this into consideration when pricing your work.
- Prices will be listed in one picture frame included in the exhibition space.
- There are 15 Places for small / medium size artwork in the exhibition (between A4 and A3 size):
 - Artwork will be accepted by Katharine on a first come first serve basis between 1st September 26 and 27th September 26
 - If over subscribed, we will store some artwork to replace any that are sold but cannot guarantee these will be shown in the exhibition.
 - If under-subscribed an opportunity for already participating artists to enter a second piece will be given
- A Trust telephone number will be displayed which people can ring if they wish to purchase a picture. The Trust will then pass on the details to Katharine (organiser of the Art Club) to make arrangements for payment with the client. Payment will be made to the artist at the end of the exhibition after the 20% Trust commission has been paid.
- Pictures may be removed and replaced during the exhibition by arrangement with the Trust Coordinator.
- Paintings must be removed on the date specified by arrangement. (24th October by Katharine)
- Unsold paintings will be available to collect from Katharine at her studio skorkart. Please collect your artwork before Christmas.

We will not accept any images that demonstrate a political bias, obscene or horror images or contravene copyright law. This list is not exhaustive.
