



Club Rules:

1. Please be polite and considerate to others.
2. Please leave your workspace, as clean and tidy as you found it.
3. Please follow any instructions given to you by staff of Skorkart, or Halfpenny Green Wine Estate. It may involve your safety.
4. The Art Club intends to be a no pressure environment, you do not have to participate if you don't want to.
5. Any concerns, issues or suggestions should be raised privately with the organiser.

Club Terms and Conditions:

- The Art Club, Skorkart and Halfpenny Green Wine Estate is not responsible for injury or loss of property.
- Guests take part in meets, events and activities entirely at their own risk.
 - Halfpenny Green Wine Estate, Skorkart and the adjoining craft village are fully operational workplaces. Please be mindful when visiting as certain areas, such as the vineyards and bottling plant can be dangerous.
- Any sharps (scalpels, knives, scissors, needles), should be kept secure and used with care and at their users own risk. Sharps can only be used with relevant protective gear e.g. a cutting mat with a scalpel.
- Any damage to furniture or flooring will incur a fine payable by the individual responsible; amount determined by Halfpenny Green Wine Estate
- The attendance fee for each regular session of the club; goes towards the club costs, room hire, refreshments and Skorkart for organisation time.
- Ticket price for age 16+ is £10 per session, for child age 12 – 15 it is £8 per session.
- Tickets must be booked in advance through the website, unless pre arranged with the organiser under special circumstances.
- Tickets are non-refundable but can be transferred to another date if the organisers are notified by the Sunday before the art club session. (48hrs before)
- If a member does not attend a prepaid session the cost will not carry over. This applies to cancellations within 48hrs of the session, on the day cancellation or no shows.
- If the art club is cancelled by organisers the value of the missed session will be carried over to another session.
- We provide complimentary tea/coffee cakes and biscuits for the evening. We cannot guarantee that allergies and dietary requirements will be catered for.
- You are invited to join the Art Club WhatsApp group. The intended use for the group is for organisers to update members with upcoming session information. You may ask questions related to Art club to the organisers this way, or privately. Please no spamming or sharing information that is not related to Art Club in the group.
- Please try to keep group contact between the hours of 9am and 8pm as courtesy to others in the group.
- Information and questions will be shared and answered between the hours of 9am-8pm
- EVENTS - Occasionally The Art Club may hold events by a 3rd Party, for members to partake in. These are entirely optional, however,
 - an additional cost will be involved which will be determined by the 3rd Party. Events may involve but not limited to; classes, talks, demonstrations, exhibitions.



- Event fees will be instead of club meet attendance fee
- A no tolerance policy for behaviour will be in force. Anyone found in breach of this will be asked to leave.
- The Art Club is part of the Skorkart brand and business.
- The Art Club retains the right to revise the Terms and Conditions, Rules or Club fees as they see fit to requirement.
- The Art Club reserves the right to limit the use of some materials, due to the potentially hazardous nature or impact on the room hire/environment. Any concerns please discuss with the organiser.

Privacy Policy:

- The Art Club and Skorkart (The business) will not share, sell or rent any personal information it collects.
- The business, will only share any information where it is of legitimate interest to the guest, such as booking on to a The Art Club event with a 3rd party. Where possible, guests will be informed if this is the case.
- Please be aware photos may be taken of meets and events for marketing and social media purposes. Please speak to the photographer at the time if you do not wish to be included.
